A 54-year-old man from Bartonville has been killed in a single-vehicle crash in Camden County, Missouri, according to the Missouri State Highway Patrol. The incident occurred on Saturday, July 12, at approximately 12:45 a.m., when the driver of a sport utility vehicle lost control and struck a tree, causing the vehicle to overturn. The medical examiner from Camden County pronounced the man dead at the scene. His name has not been released yet. Camden County is located in central Missouri near Lake of the Ozarks State Park.
